# Business Manager's Report

Dear Brothers and Sisters,

I write this report with both happiness and sadness in my heart. Black Schroeder has tendered his resignation as Business Agent for Texas. I met Black about 38 years ago when we welded together on a sled job where Buddy Kervin was the Welder Foreman. Black has been an outstanding Business Agent. But more than that, he devoted a large part of his life to Local 798 and its principles. He is my friend, and I will miss him as an agent, but I am happy that he is entering a new chapter of his life. I wish him the very best in his well-deserved retirement.

I have selected Joe Gaines of Dalhart, Texas, to be the next Business Agent. Joe is a 20-year member and respected by his peers to be a craftsman and a good union man. Joe will shadow Black beginning November 2 to help orientate him to the expected job duties.

The work outlook is still slower than we would like to see, but some positive things are happening. The Mountain Valley Pipeline has five spreads of work that are pre-jobbed to complete. Enbridge Line 3 looks very positive to start some of their work in the next few weeks. Currently, we are working on the stations and modifications on existing stations for the Keystone XL. The Mainline is scheduled for 2021, which will be ten spreads. Man-hours at the end of September were at 4 million with three months left to complete 2020. This year will probably turn out to be the lowest man-hours we have experienced in the last 14 years. We don't have a magic wand, but we do have the Action Network. We must continue to be diligent in our fight for pipeline projects. Whether on your phone, laptop, or home computer, advocating through social media only takes a few minutes of your time. Please get involved, so our voice becomes louder. Advocating works, the clients depend on it, and it will bear fruit, but you must participate.

During these slow times and for the future, our training center is a great place to expand your skill sets. Many of our members have been working building trades for the last few years through our sister locals to maintain their benefits and spot on the wheel. If you need to broaden your skills or just brush up, the training center has some of the most talented instructors to help you to achieve your goals.

Last, but certainly not least, this nation is at a crucial crossroads with the presidential election bearing down on all of us. Every day, all day, and all night, we are bombarded with both parties shouting at us for our vote. We must vote; we must stand up for what we believe is just and right. Please look carefully at what both parties want for America and ask yourself, "What is best for my children or my grandchildren?" God bless America, and God bless 798.

However, it seems the work continues to be delayed. There are several good jobs that I am keeping an eye on, but at this time, there is no definite start date. The work in Nevada that I spoke of previously looks to be delayed until early next year. It is hard not to feel that the gas companies realize the uncertainty of the upcoming election. The 2020 COVID-19 pandemic has cost our members, contractors, and clients several jobs that I believe would have kicked off this year. My entire life,

I've heard there will be plenty of work for everyone in an election year. That did not come true this election year partly due to the virus but mainly due to the environmental groups and the politicians that want to kill fossil fuels. If you are not registered to vote, please do so and vote for the candidates that support our way of life to make a living.

Now for some good news. I have four TC Energy Keystone XL pump stations kicked off in Montana and South Dakota that will run into 2021. I expect to pre-job the fifth station in Oklahoma mid-to-late October. There are 26 of these KXL pump stations to be built and over 800 miles of 36" Mainline pipe to lay in the spring. The Mainline work is split into ten spreads to kick off in 2021. Associated will kick off several HDDs on spread 6A in South Dakota in late October.

The Line 3 Pipeline Replacement Project consists of 350 miles of 36" split into six spreads, eight pump stations, and 32 Mainline valves in Minnesota. Michels has just finished the 12-mile section of Line 3 in northwest North Dakota to the Minnesota border. Precision will pre-job the second week in October to fabricate their portion of the Mainline valves. Mainline pipe and stations should start in late November or early December.

You and your local union have fought for the last ten years for the KXL permits and the last six years for the Line 3 Replacement permits. Thanks to everyone who traveled to the Town Hall meetings and participated in the 798 Action Network to have our voice heard. Thanks for stepping up when called on.

Our union leaders have negotiated a Project Labor Agreement for both projects that guarantees all work - every nut, bolt, and welding rod - is completed by 798 skilled labor. I could not ask for a better Christmas present to get our people back to work. I wish everyone a very happy holiday. God bless all and this great country.

The work in the Northeast is starting to pick up a bit with the MVP beginning to pre-job. Three spreads in West Virginia are pre-jobbed, and I just received solid start dates on the two spreads in Virginia. The bulk of the hiring has not happened, and the spreads are currently getting set up to go when the permits are approved.

The U.S. Fourth Circuit Court of Appeals overturned three permits that were previously granted, and in doing so, caused our current situation. The first permit, reissued in early September, is the U.S. Fish and Wildlife Service for Endangered Species permit. The second permit involved is the Nationwide Permit 12, issued by the Army Corps of Engineers. This permit was rereleased in late September and allows the pipeline to cross approximately 1,000 creeks and rivers. The third permit, which has not been granted, is issued by the U.S. Forest Service and will allow the project to pass through the Jefferson National Forest. Although the National Park Service, which is separate from the Forest Service, did grant permission to pump natural gas at high pressures through a portion of the MVP to be installed under the Blue Ridge Parkway.

Mountain Valley recently asked the Federal Energy Regulatory Commission to lift their stop-work order since the permits listed above are being reissued. And on Friday, October 9, 2020, FERC lifted the stop-work order and granted a two-year extension to their permit. The environmentalists will continue to file injunctions and try to convince judges to rule their way, but I think the project will be completed.

If you do go to work on the MVP, please carry yourself in a professional manner knowing that you represent Local 798 in the communities where you work. I also want to ask that we follow all state, federal, and company policies regarding the latest COVID-19 protocols. I have participated in several public debates with environmental groups that want to shut the MVP down due to the spread of COVID-19, and I know that they will be out there looking. If we follow the guidelines and do what is asked of us to help stop the spread of COVID-19, the other side will have nothing to discuss. Also, if they treat you poorly in the community, please turn the other cheek and always take the high

road. The environmentalists are constantly looking for ways to shine a bad light on us when all we are doing is trying to make a living. Please don't let them be successful.

# DISPATCHReport

Double-check your out-of-work cards! You need to make sure you are willing to apply for everything on your out-of-work card. It is the worst part of my job to get someone on the phone preparing to dispatch and realize they do not have everything checked that is required for the job they are applying for. You can change your card immediately, but according to the Dispatch

Policy, it does not go into effect for 48 hours. You can then apply if the job comes up again.

We've had some jobs come up with stick and automatic test. You must have automatic on your card if any part of the test uses an automatic type machine (BUG). Also, there have been some jobs requiring handheld wire. Be aware of any job that requires automatic, handheld wire (up or down), and downhill LH. The contractor must provide training and practice coupons before you test. They do this because the automatic technology changes rapidly, and handheld is a rarity in our trade. Also, the downhill LH comes around and then disappears for two or three years, then makes a comeback. So please double check your out-of-work card.

The building trades work is getting a little better. If you have a UA 101 cert, we have work. This is a wire bead with flux core fill and cap. We have also had calls for schedule 10 stainless welders and have not been able to fill them.

Get to the training center and expand your skill sets. Here in Dispatch, we are continually looking for building trades work during this slow time. We have members working steadily on building trades while waiting for their name to come up or work to break. These are members who have done this for years now. It's easier for them to travel to locals they have worked at before. We only hear from them when they want a BIO sent to the local they are going to.

### IMPORTANT PLAN CHANGES

The Board of Trustees of Pipeline Industry Pension Fund (PIPF) and Pipeline Industry Benefit Fund (PIBF) met on September 8, 2020, and approved plan changes. These important pension plan and health and welfare plan changes will affect active participants, spouses, children, and retirees. The PIBF office recently sent a document titled Summary of Material Plan Modifications dated October 2020, which outlines all the recent changes. Several highlighted changes include:

- An extension for those working retirees over 62 to earn full accrual benefits for PIPF was granted through December 31, 2022.
- The Trustees have again approved the continuance of the PIBF Health Reimbursement Account (HRA) for 2021. The HRA benefit will continue to be \$4,000.00 per year for active members for single or family coverage. Active members on COBRA will continue to be \$4,000.00 per year for single or family coverage. Separate coverage for spouses and children who are on COBRA is \$2,000.00 per year. The HRA amount for a retired member with covered dependents is \$4,000.00 per year and single retired members, and retired widows is \$2,000.00 per year. The HRA filing deadline for 2020 is April 15, 2021.
- Effective September 8, 2020, the exclusion for injectable medications has been removed. Most injectable medications are still subject to the PIBF and CVS internal review process, which considers dosage, quantity, safety, cost-effectiveness for route of administration, and appropriateness of use based on diagnosis.

# MDLIVE - Virtual Medical Visit Option

The MDLIVE program launched May 1, 2020. Hopefully, you have all registered and set up a profile for you and your dependents to use should you need the service. It is a great idea to do this in advance of your first virtual visit. If you have not yet registered, you can now get to the MDLIVE website by clicking on the MDLIVE logo on our homepage, www.pibf.org. As a reminder, this is a virtual medical visit program offered by BlueCross BlueShield for active and COBRA participants and for participants where PIBF is the primary coverage. This program will give 24/7/365 access to speak to a doctor from any location. Co-payment for this service will be \$15 per visit. This co-payment will not count toward your annual medical benefits deductible or out-of-pocket expense limit. It will be eligible for reimbursement under the Health Reimbursement Arrangement (HRA) by submitting your Explanation of Benefits (EOB) with a completed HRA Claim Form. Details about the program and instructions on how to participate have been mailed to the membership. In addition, you should have received a new Medical ID card listing the MDLIVE information.

Are you getting enough sleep?

According to an article by Lawrence Epstein, Mb, "Sleep deprivation is widespread across the United States." Following are excerpts from his article as published in the International Foundation of Employee Benefits Magazine in July 2019:

"According to the Centers for Disease Control and Prevention (CDC), 35% of U.S. adults are not sleeping seven or more hours per night, as recommended by the American Academy of Sleep Medicine (AASM), making sleep deprivation a public health problem. Think about the typical sleep schedule. How many people sleep at least seven hours a night on a regular basis? Chronic insufficient sleep leads to an increased risk of several serious health problems, including cardiovascular disease, hypertension, and type 2 diabetes. Research also suggests that poor or insufficient sleep may contribute to the development of Alzheimer's disease. Lack of sleep also has a profound impact on feelings and mood. According to a review published in the International Journal of Environmental Research and Public Health, there are direct correlations between lack of sleep and occurrence of anxiety and depression, which have negative effects in the workplace. Conversely, regular, healthy sleep can help drive a more positive outlook, enhancing the ability to recognize the emotions of others, in turn improving relationships at work and home."

#### 2021 Convention Delegates/Alternates Mail Ballot Election

- 1. The General President has directed that the election for delegates be conducted by mail ballot. There will be no manual balloting.
- 2. Election Services United (ESU) shall administer the election. ESU is headquartered at 672 Dogwood Avenue, Suite 395, Franklin Square, NY 11010. The ESU representative conducting the Local 798 election is Sandee Tovin. ESU has advised that it will utilize the services of Impala Press Ltd. Impala Press Ltd is located at 931 South Second Street, Ronkonkoma, NY 11779
- 3. Ballots will be mailed to all eligible Local 798 members on Wednesday, October 28, 2020, at their most recent permanent address on file with the Local Union ("primary address") as of Friday, October 16, 2020.
- 4. No Local 798 member shall be eligible to vote in the election unless they have been a member of the United Association and Local 798 in good standing for at least a period of one (1) year immediately prior to the date of the election. Any member who owes or has paid a reinstatement fee within a period of one (1) year immediately prior to the date of the election shall not be eligible to vote. The "date of the election" for purposes of determining eligibility to vote is Wednesday, October 21, 2020. Thus, if a member is not eligible as described above as of Wednesday, October 21, 2020, they will not be eligible to vote.
- 5. Members who do not receive a ballot, or who need a "duplicate" ballot must contact ESU directly at 1-800-971-3960. Thus, for example, if a member does not receive a ballot at the address provided to Local 798, or is no longer receiving mail at that address, they may request a duplicate ballot from ESU. Members must call personally to obtain a duplicate ballot; they may not have another individual call for them. The member will be asked to provide identifying membership information (such as book number or social security number) to obtain a duplicate ballot. ESU will provide the member with a confirmation number.
- 6. To be counted, ballots must be returned to the Tulsa, OK, U.S. Post Office box printed on the outer return envelope by 9 a.m. CST on Thursday, December 10, 2020. Any ballot that is returned to the post office later than this date and time will not be counted. Ballots will be counted on Thursday, December 10, 2020, at the Local 798 Union Hall, 4823 South 83rd East Avenue, Tulsa, OK, starting at 9:30 a.m. CST.
- The results of the election will be announced at the Regular Membership Meeting on Friday, December 11, 2020, starting at 7 p.m. CST at the Local 798 Union Hall, 4823 South 83rd East Avenue, Tulsa, OK.
- 8. In the event there is a tie vote in a delegate election and a run-off election is necessary, a mail ballot election will be conducted for only those delegates for which there is a tie vote. Ballots will be mailed on Friday, February 26, 2021, and will be counted on Monday, April 5, 2021, at the Local 798 Union Hall, 4823 South 83rd East Avenue, Tulsa, OK, starting at 9:30 a.m. CST. The results of any run-off election will be announced at the Regular Membership Meeting to be held on Friday, April 9, 2021, at the Local 798 Union Hall, 4823 South 83rd East Avenue, Tulsa, OK, starting at 7 p.m. CST.

# PIPELINERS VOLUNTARY FUND SCHOLARSHIP PROGRAM

In January 2021, following the conclusion of the Fall 2020 semester, the Pipeliners Voluntary Fund Scholarship Program will award ten general scholarships of \$3,000 each. A screening committee will select the winners from the qualifying applicants. Any Local 798 member or his/her immediate family (spouse, child, or grandchild), who has graduated from high school and is currently attending at least the first semester of an accredited college, may apply. Both undergraduate and graduate students are eligible.

The Voluntary Fund has sponsored the Scholarship Program since 1969. The Scholarship Fund owes its success to the generous contributions of the Local 798 membership. Thanks to all of you for your continued support. The Harry Faucett, Jr. Memorial Scholarship, in the amount of \$7,500, will also be awarded. It has been funded by Voluntary Fund donations, memorial donations in honor of Harry Faucett, and through the generous contributions and sponsorships at the annual golf tournament. This scholarship is awarded to the highest-ranking applicant meeting the qualifications for the Voluntary Fund Scholarship Program. Only applicants who have maintained a minimum 3.2 GPA in their college-level coursework will be considered for this award.

Application forms for the 2020-2021 Scholarship Program are now available for students enrolled in the Fall 2020 semester. Written requests should be addressed to Pipeliners Voluntary Fund Scholarship Program, PO Box 470798, Tulsa, OK 74147-0798. Applications may also be downloaded online from the Local Union 798 website at www.local798.org. The application is available under the Voluntary Fund tab in the Scholarships section.

An instruction sheet accompanies the application and appraisal forms. Adherence to the rules and compliance with the requirements are necessary to be eligible for consideration in the final screening process. Completed forms should be returned along with copies of all previous college transcripts. It is the applicant's responsibility to have their college or university registrar's office immediately mail in a transcript of their grades upon completion of the Fall 2020 semester. Sufficient time is allowed for the receipt of fall transcripts, but a cut-off date is necessary to process all applicants through the screening committee. Applicants will be disqualified if all materials, including the application, appraisal forms, and transcripts, are not received by the January 22, 2021, deadline.
