Business Manager's Report

Dear Brothers and Sisters,

Congratulations to the newly elected officers and all the candidates who participated. I would also like to thank the members of the Election Committee, John Werner, Greg Russell, and Tracy Lester, for their due diligence and professionalism in ensuring that the election was conducted according to Department of Labor rules and guidelines.

The next three years could be the most challenging for our members as we anticipate the bulk of the new lay will be in Texas, a state that we struggle with, against nonunion wages that do not include a benefits package. Decisions will not be easy or comfortable to try and level a playing field dominated primarily by unscrupulous contractors for far too long. We have been utilizing the Market Recovery as a weapon to make our contractors competitive, but unfortunately, their success rate has been dismal. We have had several meetings and frank discussions with labor and contractors willing to bid in that market. Deliberations continue, and we will build a new weapon to fight this battle. The fight against sub-standard wages and no benefits has always been the enemy of the working man regardless of the industry you work in.

The work outlook hasn't changed much, but I still believe 2023 will be slightly stronger than 2022. Integrity Maintenance work is still strong and growing as our pipeline systems age. There is a large volume of pipeline work on the books but politics and permitting will impact whether they are constructed sooner rather than later. Building trades work through our sister locals will still be red hot after the first of the year for those who want to participate. We have connections with the locals; we have the instructors to help build your skill sets; all we need is for you to reach out.

Pension improvements were not considered at our last PIBF trustee meeting due to poor performance in the market. Our pension fund remains healthy and solvent at over 100 percent, but market futures continue to be volatile on a day-to-day basis. We beat the index in all categories of investments, but unfortunately, the index numbers were all negative, so there were no gains, only losses.

This report may seem all negative to some, but the truth is, this union and my position as your business manager is always challenging, in good times and bad. I pledge to you that I will continue to work to preserve our rightful place as the leader of the pipeline industry and strive to work for the betterment of all members of 798. ***As always, "I work for you, the greatest pipeliners in the world."***

Dear Brothers and Sisters,

I hope each of you was able to spend time with your loved ones during the holiday season. The votes for the 2022 Officer Election were counted on December 8, here at the Union Hall. You will find the results in this issue of the Blue Light. I appreciate the support I've received and am truly honored that I was unopposed for the position of Financial Secretary-Treasurer. Elections are healthy, but the slander and misinformation that sometimes comes with elections are not. I ask the membership to get behind and support the duly elected candidates going forward. We are stronger when we are all pulling in the same direction. Congratulations to all the candidates and those chosen to represent this membership for the next three years.

We are actively engaged in organizing campaigns in several parts of the country right now. No, we will not divulge the details of our organizing on any social media platform for obvious reasons. We have also met with the other crafts and the PLCA on the subject of securing market share in Texas. This is no easy task. Honestly, it seems like quite an uphill battle we face. There are no easy answers to how to get back into this market. The work has gotten cheaper and cheaper, and we aren't getting enough of it, even under the Market Recovery conditions. We often hear, "Why aren't we doing this work?" and then, it's "Why did we give concessions on this project?" sometimes from the same people. We have to ask ourselves, can we take back this work at full rates and working conditions? It's not going to be easy in Texas. This was recognized in 2018 when the crafts and the PLCA collectively put together the Market Recovery package to make a run at the work down South. We are going to continue meeting collectively to take this work back. It will not be easy, and some of what we will have to do will be painful, but we can't let the nonunion continue to flourish in that market. The bulk of big-inch projects over the next several years will be in Texas and Louisiana.

I know we push this to the extreme, but I can't tell you how vital the Action Network is to us in securing more work. Don't let anyone tell you it doesn't work. Don't ever let anyone tell you this is all we are doing either. Many of the actions we run are because we are specifically asked to do so by the client/gas company. They reach out to Danny or me, or through the business agents and organizers, and tell us what the need is. We've had positive feedback recently from Williams, Enbridge, Tellurian, etc., on how our partnership is strengthened through our use of the Pipeline Action Network. Please help us with this. Spread the word and get everyone you know to sign these actions. Every click helps. If you've got information that may be helpful to our organizing efforts, please reach out to Chad Simmons, Charlie Thomas, or Ronnie Hill. I assure you these guys will follow up on any promising lead. We are all in this together, so let's work together for the betterment of this local union. Opportunities are coming up in several parts of the country for involvement at public hearings for pipeline projects. These carbon capture projects will need our help all along the way. There's a lot of work for us to do, with new proposed projects also popping up. Please stay involved!

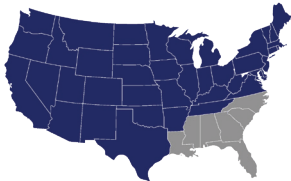

I am writing this report after returning home from the December Membership Meeting in Tulsa. We had a good turnout, and it was good to see and visit with everyone in attendance. I want to congratulate all the elected and re-elected officers.

I have been visiting with other locals, gas companies, and contractors. Our contractors tell me that they are bidding on work and that the Integrity Maintenance work looks better for next year.

I recently attended a meeting in Tipton, Iowa, regarding the Wolf Project. This is one of three carbon capture pipelines, and they are still in the process of holding informational meetings. This project will be about 280 miles of 4" to 20" pipe, with 190 miles in Illinois and about 90 miles going through Iowa. It is in the early stages, and if all goes well, it will begin construction in the second quarter of 2024. Mark Antczak, business agent for Local 597, and I attended the meeting and can see there is some opposition to this project. We talked before the meeting to the vice president/engineer from Wolf Carbon Solutions about using union labor. He acknowledged that our support for the project by using our Action Network and attending future meetings could be a huge asset. He also spoke of plans to talk to the four crafts, but it is still early in the project. As members, we must continue to stay involved in the Action Network.

I recently received a call from a superintendent from a building trades job saying thanks to 798 for manning their job. He told me our members did a great job and had a good work ethic. This is always great to hear.

While in Tulsa, I visited the 798 Training Center and was glad to see so many of our members taking advantage of it.

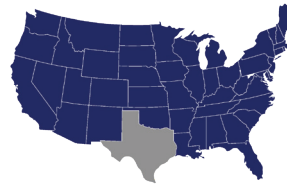

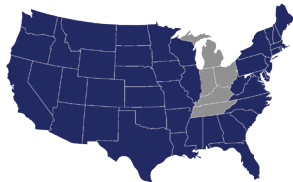

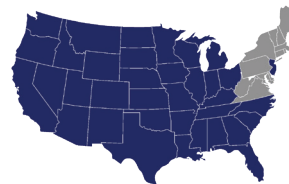

I hope that everyone had a Merry Christmas and a happy New Year. I have just returned from the December meeting, where we found out who our officers will be for the next three years. I congratulate all who won, and I commend all those who had the resolve to run for office. The fact that you ran shows you care about this great local and its progression. Local 798 was chartered 73 years ago, and this group of elected officers is tasked with steering and guiding this local on a path of sustainability so we can be around for 73 more. I pray those elected take this obligation seriously and truly understand how important their duties are to our success.

The work in the Northeast is currently slow due to the holidays, and I am pre-jobbing less than I do in the spring/summer. I hear from the contractors that there is more work out to bid in 2023 than in 2022. I think we will continue

to see most of our work being done in the maintenance, gathering, and compressor station sectors as the large-diameter transmission mainlines in the Northeast continue to be plagued with permit issues. Permitting reform will be necessary to unlock development in carbon capture and hydrogen ventures along with fossil fuel projects. My sources on Capitol Hill tell me there is a strong appetite for permitting reform amongst the politicians. And many of them know that the \$370 billion the Inflation Reduction Act dedicates to energy will not be able to be spent due to roadblocks put in place by the "Not in My Back Yard" movement.

I am frequently asked what is going on with the MVP. The United States Forest Service and Bureau of Land Management permits, which have been reworked, will be decided on by the Fourth Circuit Court of Appeals in the summer of 2023. If the permits receive a favorable review, we will return to work on MVP next summer. I would like to see a legislative permitting reform bill passed before the court rules because I am hesitant to trust the Fourth Circuit's judgment due to past decisions they have made on the MVP. Time will tell how this plays out, but you can rest assured that we will keep close tabs on this and help in any way possible to get MVP over the goal line.

As December has ended, so has our election. Congratulations to all those who ran. Whether you were elected or not, you put yourself out there to help this great local union, and your continued positive involvement is needed.

We are embarking upon a new year with many opportunities and challenges ahead. Numerous gas companies we have spoken with are looking to lay new pipelines. Some of these are in conjunction with LNG exports along the Gulf Coast. One example is Tellurian's Driftwood project, which will be built with union labor. By the time you read this report, we will have attended a town hall meeting in DeRidder, Louisiana, for Driftwood Pipeline's Indian Bayou Compressor Station with approximately 20 of our members. Thank you to each of you that came to show your support. Attending these town hall meetings is so vital to the success of a project. Please participate if you are available and continue to support the Action Network. Several gas companies have commended our efforts in both.

As far as the work is concerned, you need to be a model employee, so when the real reason for being there is revealed, there would be no legitimate reason for being fired due to your work record. It's imperative that salts do not discuss any activity with anyone unless instructed to by whoever sent them there. It's a job like any other, and there is one reason for being there and only one reason. If the opportunity arises, and it seems it will be beneficial, and the right people are available that are sincere and disciplined for this, then we will certainly do it." One of the biggest hurdles we face in the organizing world is ourselves. When meeting with gas companies and contractors (union and nonunion), we get asked about all the dissension on social media. COBRA Coverage

Effective March 1, 2023, COBRA rates will be as follows:

- Single Coverage \$640 per month
- Family Coverage \$1,700 per month

Eligibility Rules Amended

Trustees amended the Plan (effective January 1, 2023) to change initial eligibility for new journeyman participants who enter the Plan on or after January 1, 2023, or who have lost eligibility for 60 months and are re-establishing eligibility from the 500-hour requirement to an 800-hour requirement. The hours must be worked within a 12-month period. Eligibility rules for helpers remain at 800 hours.

Virtual Medical Visit Option Expanded to Include Behavioral Health and Co-Payment Amounts Changing as of April 1st

Beginning April 1, 2023, the MDLIVE program will include the option for behavioral health visits. MDLIVE is a virtual medical visit program offered by BlueCross BlueShield for active and COBRA participants and for participants where PIBF is the primary coverage. This program gives 24/7/365 access to speak to a medical provider from any location. Co-payment for this service will be 30% of the cost of the visit. For a medical visit, the co-payment will remain around \$15; however, co-payments for behavioral health will depend on the length and level of the visit and the credentials of the medical provider. This co-payment will count toward your annual medical benefits deductible and out-of-pocket expense limit. It will be eligible for reimbursement under the Health Reimbursement Arrangement (HRA) by submitting your Explanation of Benefits (EOB) with a completed HRA Claim Form. Plan exclusions apply (treatment of substance abuse, etc. See the PIBF SPD at www.pibf.org, pages 53-55, for a complete list of plan exclusions). Please know that MDLIVE is experiencing high visit volumes due to COVID-19 and the cold and flu season and wait times may be longer than normal.

Disability Pension Benefit Suspension and Reinstatement

If your disability pension benefit is suspended because you were not approved for your Social Security Disability benefit within 24 months, upon receipt of the Social Security Award, the Trustees shall retroactively reinstate the Disability Benefit from the date of suspension, commencing on the first day of the first month following receipt of the Social Security Award, provided that the date of disability as determined under the Social Security Award is within the 24-month period.

Tax Forms Available on Member Portal

Tax form 1099R (Pension Payments) will be mailed to you by the end of January, and tax form 1095B (Health Coverage) will be mailed to you by March 2, 2023. These forms are also available on the member portal at www.pibf.org. Log in, click on the "General Information" tab, and then "Fund Office Correspondence." A list of correspondence will display, and you can select and print the forms.

Email Addresses and Other Personal Information

To remain HIPAA compliant, PIBF and Local 798 do not share change of address information. It is extremely important that plan participants notify both 798 and PIBF when permanent address changes occur or when email or telephone numbers change. You can change your address by mail, by calling the Fund office at 918-280-4800, or by going online to www.pibf.org, logging in to the "Members Login" section, and choosing "Change of Address Form" under the "Forms" tab.

Deductibles Renew January 1st

Please remember that medical and prescription deductibles start over at the beginning of the year. The PIBF office receives a large volume of calls early in the year, questioning the price increase from their last refill. In most cases, this is due to the deductible having to be met before the prescription is covered with co-insurance.

Health Reimbursement Arrangement (HRA)

The HRA deadline is fast approaching for 2022 claims. Don't leave money on the table! Remember to file for reimbursement of your 2022 claims by April 15, 2023.

Summary of Benefits and Coverage

The PIBF office recently mailed out the Summary of Benefits and Coverage, describing what the benefit plan covers and what it costs. This is a condensed version of our PIBF Summary Plan Description booklet showing comparable information about your health plan benefits and coverage.

Retirees – Working Rules Before Age 62

The Internal Revenue Service (IRS) imposes rules that limit a retiree's ability to immediately return to work in the industry after retirement if the retiree is under age 62 (age in service rules apply). Penalties could be imposed upon the participant by the IRS.

An exception to this was granted in previous years because Local 798 was experiencing a manpower shortage. ***Because a manpower shortage was not anticipated for 2022 or 2023, an exception to this rule was not in place for 2022 and will not be in place for 2023.*** Therefore, the rules of the Pipeline Industry Pension Plan (PIPF) will again apply. The PIPF office will again impose accrual limitations for work performed on January 1, 2022, and later.

The IRS imposes penalties on both the PIPF and retirees who retire before age 62 and continue to work in the industry on jobs covered by the National Pipeline Agreement, Distribution Agreement, Participation Agreement, or similar agreement. If you retire and consistently work under agreements previously mentioned or in any employment capacity with a contributing employer or business entity within any "controlled group of employers," the IRS may impose excise taxes on your retirement earnings and require a revocation of your pension. Should you elect to retire, the Trustees will take action to revoke your pension should hours consistently be received by PIPF.

Year-End Statements

Your monthly dues, Voluntary Fund, and working assessments paid for 2022 are available to you on the Member Login section of the Local 798 website. Once signed in, click on the payment history page, and enter any year period to view the total amount of monies paid during that time. To view your working assessments and organizing fees paid, you must go to the work hour page and enter the date range you need, it will give you the totals for that time frame. **Please remember, hours are typically reported 30-45 days behind, so if you worked in December, those working assessments will not appear until late January to mid-February 2023.**

Your emailed year-end statements will not be available until after February 20, 2023. If you do not have an email address on file, your year-end statements will be mailed to your home address. We will be working diligently to get this information out to all members, so we will be unable to provide the information over the phone prior to that date. However, you may obtain this information when logged into the Member Login section of the website as indicated above. Please keep in mind that it is our goal to provide the membership all the information they need, while striving to do so in the most cost-efficient ways possible.

It definitely puts pipeliners in a good light when we reach out to the communities we work in. If we all put God first, everything else will fall into place," says Davis.
